

## **Statute of the Albert Ludwig University on the collection of tuition fees for the continuing education course Master of Science Periodontology and Implant Therapy**

On the basis of section 2 and section 13 paragraph 1 of the State Higher Education Fees Act (LHGebG) from 1 January 2005 (Law Gazette, p. 1, 56), last amended by article 6 of the Act from 1 April 2014 (Law Gazette, p. 99), and section 19, paragraph 1, clause 2, number 10 of the Baden-Württemberg University Act (State Higher Education Act – LHG) from 1 January 2005 (Law Gazette, p. 1), last amended by article 2 of the Act from 23 February 2016 (Law Gazette, p. 108), the senate of the Albert Ludwig University adopted the following statute in its meeting on 29 June 2016.

The chancellor granted approval on [date] in accordance with section 2, paragraph 2, clause 2 of the LHGebG.

### **Section 1 Tuition fees**

The Albert Ludwig University collects tuition fees from students for the subjects offered in the continuing education course Master of Science Periodontology and Implant Therapy.

### **Section 2 Schedule of tuition fees**

(1) The tuition fees for the normal duration of study of six semesters is a total of €29,000. For each additional semester of study a tuition fee of €4,500 must be paid.

(2) The tuition fees as defined by paragraph 1, clause 1 are due with notification of the fee schedule as follows:

1. for the first to the fourth semesters, €5,000 for each semester due by the 15th of the month in which the particular semester starts, and
2. for the fifth and sixth semesters, €4,500 for each semester due by the 15th of the month in which the particular semester starts.

Tuition fees as defined by paragraph 1, clause 2 are due with notification of the fee schedule and must be paid by the 15th of the month in which the particular semester starts.

(3) If a student who has suspended their studies as defined by section 61, paragraph 2, clause 1 of the State Higher Education Act makes use of the option to participate in teaching sessions and to submit assessments and sit examinations, paragraph 2 also applies.

### **Section 3 Waiving of fees and refund of fees; fee dispensation**

In case of withdrawal from a course, upon application by the student the admission and examination board for the continuing education course Master of Science Periodontology and Implant Therapy can waive the tuition fees in part or in full provided the student is able to provide a compelling reason why he or she is not able to start or continue the course and for which he or she is not responsible. Tuition fees that have already been paid can be refunded under the same conditions. There is no dispensation of fees.

### **Section 4 Fee reduction as a result of recognition of previous academic achievements and professional experience**

If previous academic achievements or professional experience are to be recognised for the continuing education course Master of Science Periodontology and Implant Therapy, the tuition fees that are to be paid are reduced by €5000 for students who have successfully completed a curricular postgraduate

course in periodontology certified by the State Dental Association of Baden-Württemberg and by €2000 for students who have completed a Master's in the field of implant dentistry.

### **Section 5 Commencement and transition provision**

This fee schedule comes into force on 1 October 2016. At the same time, the statute of the Albert Ludwig University on the collection of tuition fees for the continuing education (Master Online) Master of Science Periodontology and Peri-implant Therapy from 29 June 2012 (official notification vol. 43, no. 79, pp 287–288) becomes invalid. For students who enrolled in the continuing education course Master of Science Periodontology and Peri-implant Therapy before 1 October 2016, tuition fees are collected in accordance with the fee schedule of 29 June 2012.
